## *Brief History*

In 1951, business leaders in the ready-mixed concrete industry decided there was a greater strength in numbers and established the Texas Ready Mixed Concrete Association. A year later; the Texas Aggregates Association was organized. After operating for 22 years as a joint effort, with shared office and staff the two groups consolidated in 1974 as the Texas Aggregates and Concrete Association (TACA). The Association speaks for all forms of aggregate, concrete, cement, admixtures, fly ash and construction material producers and allied industries in a united effort.

### EDUCATION:

This committee is very active throughout the year. This committee meets to plan educational events like the Chat-N-Chews, Short Course, and TACAMP.

### ENVIRONMENTAL/ SUSTAINABILITY:

This committee monitors environmental issues that affect the members of TACA and acts as a liaison between governmental agencies and the membership. The committee sponsors workshops as needed for the membership on environmental issues and serves as a liaison to the Governmental Affairs Committee. This committee is responsible for the coordination and marketing efforts for TACA and its participation in the green building and sustainable design initiatives within the industry.

### GOVERNMENTAL AFFAIRS:

This committee assists the membership in developing legislation to better serve our industry and opposing adverse legislation. This committee serves as a liaison to the Environmental Committee and the Transportation Committee. The chairman of this committee also serves on the TACA Political Action Committee (TACPAC).

### INDUSTRY PROMOTION & MARKETING:

The purpose of this committee is to increase awareness of ready-mixed concrete, cement, aggregates and related products in existing markets and new market areas through active promotion and marketing programs within TACA. Specific promotion activities will be developed based on the current market. This committee merged with the Public Image Committee to make better use of our committee members. In that capacity, the IP&M Committee now works to assist the industry through positive promotion.

### MEMBERSHIP:

This committee actively promotes membership in the association to the suppliers and producers who are not currently members of TACA. The committee is also responsible for devising viable concepts to enable maximum membership retention in the association.

### SAFETY/ TRANSPORTATION:

This committee conducts the annual safety contest and plans other safety programs and seminars as needed. The committee also serves as a liaison to the Environmental Committee in planning the Environmental and/or Safety Seminar, and the Education Committee to the Short Course. This committee monitors all information relating to the transportation of materials by rail or truck, which may affect the industry. The committee also serves as a liaison to the Governmental Affairs.

### SPECIFICATION:

This committee works with the highway department on changes in the specifications for aggregates, ready-mix and other building materials. It serves as a liaison to other similar associations toward solving mutual problems and private contracting agencies or authorities.
